BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, Utilities Agreement No. 19580 with the State Division of Highways for the installation of 12-inch water main in the Euclid Avenue Overcrossing structure, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 742993.

BE IT FURTHER RESOLVED, that the use of City forces is hereby authorized to deliver and unload necessary pipe and related materials, test for adequacy of pipe construction, and chlorinate as required.

BE IT FURTHER RESOLVED, that the expenditure of \$19,500 is hereby authorized out of Water Revenue Fund 502 of The City of San Diego, solely and exclusively for the purpose of providing funds for the above work.
