That the acceptance by the City Manager of that deed of THE UNITED STATES OF AMERICA, executed in favor of The City of San Diego, bearing date of December 19, 1972, conveying to said City portions of Lots 259, 260, 274, 275, 279, 280, 281, 304, 305, 306 of the Pueblo Lands of San Diego and Blocks 347, 348, 349, 360, 361, 362, 382, 383, 391, 392 of Old San Diego for San Diego River Dyke Lands, as more particularly described in said deed, be and the same is hereby approved.

That the expenditure of \$1,500 is hereby authorized from Capital Outlay Fund 245 solely and exclusively to provide funds for costs incurred in connection with the acquisition of San Diego River Dyke Lands described above.

That the City Clerk of said City is hereby authorized and directed to file the foregoing said deed for record in the office of the Recorder of San Diego County.
