

RESOLUTION NO. 207628 MAR 27 1973

WHEREAS, Lloyd D. Heiydt, dba AMBOCAR, has applied to the City Council for a Certificate of Public Convenience and Necessity to operate automobiles for hire within the limits of the City of San Diego; and

WHEREAS, pursuant to Section 72.13 of the San Diego Municipal Code, the City Manager has caused an investigation to be made and has reported his findings in writing to this Council, which report indicates:

(a) There is a demand of the public for automobiles for hire of the type proposed in the application of Lloyd D. Heiydt, dba AmboCar;

(b) The existing transit corporation service, taxicab service and automobile for hire service do not provide transportation for persons confined to a wheelchair. This type of service requires specially equipped vehicles to accommodate loading and unloading of occupied wheelchairs;

(c) The applicant is financially responsible and will be assisted by experienced personnel;

(d) The vehicle proposed for use is a Dodge Van, Model B200, which will be equipped to handle four to six passengers, and will be inspected by the Police Department for compliance with State and local safety requirements related to wheelchair transportation vehicles;

(e) The additional service for automobile for hire posed by applicant will not result in any greater traffic congestion or hazard to the public;


(f) The proposed transportation service will not create any greater hazards to the public and will provide an economical needed service.

WHEREAS, the Council this date, after a public hearing, has found the contents of the City Manager's report to be correct and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That LLOYD D. HEIYDT, dba AMBOCAR, having filed an application for a Certificate of Public Convenience and Necessity to operate one vehicle for hire pursuant to the provisions of Section 72.11 of the San Diego Municipal Code, and the City Manager having conducted the required investigation, a Certificate of Public Convenience and Necessity is hereby granted to LLOYD D. HEIYDT, dba AMBOCAR to operate the vehicle specified in the application subject to compliance with all provisions of the San Diego Municipal Code.
