That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the CITY OF LA MESA, a municipal corporation, for the improvement of Lake Murray Boulevard, Mary Fellows Avenue to Kiowa Drive, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 743064.

BE IT FURTHER RESOLVED, that the expenditure of \$69,000 is hereby authorized out of Gas Tax Fund 220 of The City of San Diego, solely and exclusively for the purpose of providing funds for design, construction and related expenses.
