RESOLUTION NO.

A RESOLUTION APPROVING COMPREHENSIVE CITY DEMONSTRATION PROGRAM, AUTHORIZING SUBMISSION OF THE PROGRAM AND AUTHORIZING AGREEMENT FOR THE THIRD ACTION YEAR.

WHEREAS, The City of San Diego, State of California, desires to carry out a comprehensive city demonstration program (herein referred to as "Program," attached hereto and made a part hereof) with Federal financial assistance under Title I of the Demonstration Cities and Metropolitan Development Act of 1966 (herein called "Act"); and

WHEREAS, Act requires local governing body approval of Program as a condition for eligibility for assistance; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego as follows:

- 1. Program, including the projects and activities set forth therein, is hereby approved.
- 2. The City Manager of The City of San Diego be and he is hereby authorized to submit to the Secretary of the United States Department of Housing and Urban Development the revised comprehensive city demonstration program and such supporting and collateral material as shall be necessary.
- 3. The City Manager of The City of San Diego be and he is hereby authorized to execute a grant agreement with the United States of America and to do all things necessary

in order to carry out Program including the submission of such reports, certifications and other material as the Secretary of the United States Department of Housing and Urban Development shall require.

- 4. The Council of The City of San Diego assumes full responsibility for assuring that all grant funds will be used in an economical and efficient manner in carrying out Program and assures the necessary non-Federal share of the cost of Program Administration.
- 5. The City Auditor or his successor or delegate may do all things required to be done in order to obtain payment of the grant, including but not limited to the selection of a commercial bank to receive payment vouchers, the submission of signature specimens and the filing of requests for payment.
