Kurtz Contractor, for IMPROVEMENTS OF CITY TESTING LABORATORY AT ALVARADO FILTRATION PLANT, including Additive Alternates One, Two and Three, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 742551.
2.
