BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$124,971.00 by R.E. Hazard Contracting Co., a Corporation, for MODEL CITIES AREA VI-2, PAVE AND OTHERWISE IMPROVE AVERIL ROAD, BETWEEN SAN YSIDRO BOULEVARD AND SOUTH VISTA AVENUE, AND SUNSET AVENUE, BETWEEN AVERIL ROAD AND VISTA AVENUE, Schedule I, and including Additive Alternate A, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the Office of the City Clerk as Document No. 742404.
2. That the expenditure of \$129,809.00 is hereby authorized out of Model Cities Fund (Fund No. 2542) of the City of San Diego solely and exclusively for the purpose of providing funds for MODEL CITIES AREA VI-2, PAVE AND OTHERWISE IMPROVE AVERIL ROAD, BETWEEN SAN YSIDRO BOULEVARD AND SOUTH VISTA AVENUE, AND SUNSET AVENUE, BETWEEN AVERIL ROAD AND VISTA AVENUE, Schedule I, and including Additive Alternate A, in the City of San Diego, and related costs.
