


RESOLUTION No. 207648

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$160,820.00 by Guy F. Atkinson Company, a Corporation, for the SITE GRADING AND CONSTRUCTION OF STORM DRAINS IN THE MORLEY FIELD AREA OF BALBOA PARK, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 742329.
2. That the expenditure of \$125,000.00 is hereby authorized out of the Park and Recreation Bond Fund (Fund No. 725) of the City of San Diego, and that the expenditure of \$75,000.00 is hereby authorized out of the Flood Control and Storm Drain Bond Fund (Fund No. 727) of the City of San Diego solely and exclusively for the purpose of providing funds for SITE GRADING AND CONSTRUCTION OF STORM DRAINS IN THE MORLEY FIELD AREA OF BALBOA PARK, in the City of San Diego, and related costs.
