

RESOLUTION NO. 202658 APR 3 1973

APPROVING MAP OF PRINCESS DEL CERRO UNIT NO. 6 SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

Said Council hereby finds that that certain map surveyed by ARTHUR B. SHURTLEFF, Registered Civil Engineer, and entitled "PRINCESS DEL CERRO UNIT NO. 6 Being a subdivision of a portion of Lot 67 of Rancho Mission of San Diego, in the City of San Diego, County of San Diego, State of California, according to partition map of said Rancho made in the action of Juan M. Luco, et al., vs The Commercial Bank of San Diego, et al., on file in the office of the County Clerk of San Diego County.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following streets: St. Denis Terrace, Bernadette Lane, Camino Rico, Lisieux Terrace, Lourdes Terrace, and St. Therese Way, for public purposes, and said streets are hereby declared to be public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access: in and to College Avenue, adjacent and contiguous to Lots 412 through 419, 421 through 423, 429 through 431, and 442 through 453; in and to St. Therese Way,

adjacent and contiguous to Lots 492 through 500; in and to Lisieux Terrace, adjacent and contiguous to Lots 424, 425, and 482 through 491; in and to Lourdes Terrace, adjacent and contiguous to Lots 432 through 437, and 470 through 481; in and to Bernadette Lane, adjacent and contiguous to Lots 457 through 469, all as shown and granted on said map.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of drainage, sewer and water facilities, as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets are accepted on behalf of the public as heretofore stated; and that those easements with the right of ingress and egress for the construction and maintenance of drainage, sewer and water facilities; together with those certain abutters' rights of access as granted and shown on this map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
