

That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, an amendment to agreement with the STATE OF CALIFORNIA, acting by and through its Business and Transportation Agency, Department of Public Works, Division of Highways, for the construction of traffic signal and safety lighting systems at HANCOCK STREET and KURTZ STREET with CAMINO DEL RIO, in the City of San Diego, under the terms and conditions set forth in the form of amendment to agreement on file in the office of the City Clerk as Document No. 743089.

BE IT FURTHER RESOLVED, that the expenditure of \$15,000.00 is hereby authorized out of Gas Tax Fund 220 of The City of San Diego, solely and exclusively for the purpose of providing funds for the design, construction and related costs, supplementing Resolution No. 204907 in this amount.
