
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of ANDREW MATTO and ELIZABETH M. MATTO, husband and wife as joint tenants, as to an undivided one-half interest, and NICHOLAS C. ALTAMURA and JUNE B. ALTAMURA, husband and wife as joint tenants, as to an undivided one-half interest, executed in favor of said City, bearing date of February 20, 1973, conveying to said City Lots 22, 23 and 24 in Block 24 of Middletown Addition for San Diego Park District No. 3 (Mission Hills Canyon), according to Map thereof No. 384, filed November 4, 1914, in the Office of the San Diego County Recorder, as more particularly described in said deed, be and the same is hereby approved.
