1. That the bid of \$28,380.00 by Patrick J. Timmins, an Individual, for the REHABILITATION OF MONTGOMERY FIELD OPERATIONS CENTER in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 742686.
2. That the expenditure of \$29,500.00 is hereby authorized out of the Capital Outlay Fund (Fund 245) of the City of San Diego, California, and the expenditure of \$3,500.00 is hereby authorized from previously approved Resolution No. 205373 "Montgomery Field Improvements" for this purpose and other related improvements at Montgomery Field, solely and exclusively for the purpose of providing funds for the REHABILITATION OF MONTGOMERY FIELD OPERATIONS CENTER in the City of San Diego and related costs.
