BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Auditor be and he is hereby authorized and directed to transfer the sum of \$38,000 from the Torrey Pines Golf Course Improvement Fund 248 to the Capital Outlay Fund 245 in order to provide funds for improvements at the Torrey Pines Golf Courses.

That the expenditure of \$63,000 is hereby authorized from Capital Outlay Fund 245 solely and exclusively to provide funds for the construction of improvements to the Torrey Pines Golf Courses and related expenses.

That the City Manager is hereby authorized and empowered to do by City forces miscellaneous work, including sprinkler relocation, drain tile installation and turf planting in connection with the aforesaid improvements at the Torrey Pines Golf Courses.
