BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the expenditure of \$62,091.00 from Capital Outlay Fund 245 of The City of San Diego is hereby authorized solely and exclusively for the purpose of providing funds to improve radio communications capability for Police, Fire, Public Works and Water Utilities Departments, and upgrading communications operating facilities at Police Headquarters and Mission Beach Lifeguard Station.

BE IT FURTHER RESOLVED, that the City Manager be, and he is hereby authorized and empowered to do by City forces all necessary work in conjunction with the above referenced project, pursuant to the recommendation of the City Manager and the submission of his estimates indicating that said work can be done more economically by City Forces than if let by contract.
