1. That the bid of \$13,746.00 by DBX, INC., dba PERRY ELECTRIC, a Corporation, for the CONSTRUCTION OF SAFETY LIGHTING SYSTEMS ON COLLEGE AVENUE BETWEEN EL CAJON BOULEVARD AND UNIVERSITY AVENUE in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 742687.
2.
