That the offer of International Business Machines Corporation is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of 500,000 ORIGINAL UTILITY BILLS at a cost of \$7.12 per thousand, 60,000 FIRST OVERDUE BILLS at \$7.12 per thousand and 30,000 SECOND OVERDUE BILLS at \$7.12 per thousand, plus a set-up charge of \$199.80 for a total cost of \$4,400.60; terms net 30 days, plus sales tax.
