

RESOLUTION NO. 207735 APR 17 1973

WHEREAS, members of the family of George Marston, through their representative, Hamilton Marston, have generously offered to contribute to the City of San Diego the sum of ten thousand dollars (\$10,000) for the purpose of engaging an independent consultant to conduct a "regional reconnaissance" of the San Diego area including an evaluation of its assets and liabilities; and

WHEREAS, said offer is contained in a letter dated March 12, 1973, from Hamilton Marston to the Mayor and Council and is on file in the office of the City Clerk as Document No. 742891, and is hereby incorporated by reference; NOW, THEREFORE;

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That The City of San Diego hereby accepts the generous contribution of \$10,000 from the Marston family of San Diego, acting through its representative, Hamilton Marston, for the sole and exclusive purpose of retaining a consultant to conduct a "regional reconnaissance" of the San Diego area including an evaluation of its assets and liabilities. Further that said acceptance is conditioned upon those considerations set forth in the above referenced letter, filed under Document No. 742891 in the office of the City Clerk.



4. That this Council does hereby commend the Marston family of San Diego for this act of civic generosity and does hereby publicly express on behalf of the citizens of San Diego a debt of gratitude to the Marston family.
