

**RESOLUTION No. 207737**


Adopted on APR 17 1973

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. Crest Steel Corp. 2. Ducommun Metals & Supply Co. and 3. Reliance Steel and Aluminum Company are hereby accepted, and the City Manager is hereby authorized to execute contracts for the purchase of STEEL as may be required for the period of one year beginning April 1, 1973 through March 31, 1974 per prices on file in the Purchasing Department as follows:

1. Crest Steel Corp. for Section I through V, and Sections VIII, IX, XII, XIII and XIV; terms 1% 30 days, plus sales tax, and;
2. Ducommun Metals & Supply Co. for Section VI, terms 2% 10th prox, Sections VII and XVIII, terms  $\frac{1}{2}$  of 1% 10th prox, plus sales tax, and;
3. Reliance Steel and Aluminum Company for Sections X, XV, XVI, terms  $\frac{1}{2}$  of 1% 10th prox, Sections XI and XVII terms net 30 days, plus sales tax.
