


**RESOLUTION No.****207747**Adopted on APR 17 1973

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of JOSEPH and MARY RIZZO, husband and wife, as joint tenants, as to an undivided 1/5 interest; ROBERT D. WILCOX and LILLIAN WILCOX, husband and wife, as joint tenants, as to an undivided 1/5 interest; RALPH GOLDVARG and YETTA GOLDVARG, husband and wife, as joint tenants, to an undivided 1/10 interest; SEYMOUR OSTROW and PEARL OSTROW, husband and wife, as joint tenants, as to an undivided 1/10 interest; SAMUEL R. LUNDGREN and ETHEL J. LUNDGREN, husband and wife, as joint tenants, as to an undivided 1/5 interest; RICHARD C. MORAN, a single man, and PLUM MORAN, a widow, as joint tenants, as to an undivided 1/5 interest, executed in favor of The City of San Diego, bearing date of February 5, 1973, conveying to said City an easement and right of way for street purposes through, over, under, along and across a portion of the Southwest Quarter of Section 32, Township 14 South, Range 2 West, San Bernardino Base and Meridian, as more particularly described in said deed, be and the same is hereby approved and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named TREENA STREET.
