

RESOLUTION NO. 207753 APR 17 1973

WHEREAS, the City Council and the Redevelopment Agency on May 26, 1970 jointly adopted a Redevelopment Plan for the San Diego City College Redevelopment Project by Ordinance No. 10299 (New Series); and

WHEREAS, Section 700 of said Redevelopment Plan states that the City shall aid and cooperate with the Redevelopment Agency in the execution of the Redevelopment Project; and

WHEREAS, the Redevelopment Agency intends to commence certain site improvement work in a portion of the Redevelopment Project; and

WHEREAS, it is necessary and desirable that the San Diego Gas & Electric Company underground, relocate and remove its facilities in the area of said site improvement work;

NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager be and he is hereby authorized and empowered to execute for and on behalf of said City an agreement with the San Diego Gas & Electric Company for the undergrounding, relocation and removal of their facilities in connection with the City College Redevelopment Project, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 743318.
