BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a First Amendment to Agreement with RICK ENGINEERING COMPANY, a California corporation, for engineering services in connection with design and construction of Mission Boulevard, from San Diego Place to Pacific Beach Drive, including modification of existing drainage systems, in the City of San Diego, under the terms and conditions set forth in the form of First Amendment to Agreement on file in the office of the City Clerk as Document No. 743268.

BE IT FURTHER RESOLVED, that the expenditure of \$19,000 and \$17,000 is hereby authorized out of Flood Control & Storm Drain Bond Fund 727 and Gas Tax Fund 220, respectively, of The City of San Diego, solely and exclusively for the purpose of providing funds for this project and supplementing Resolution No. 203717 in this amount.
