

RESOLUTION NO. 207766 APR 19 1973

WHEREAS, The City of San Diego by Resolution No. 205331 adopted April 11, 1972, authorized the City Manager to execute an agreement with Michael Babunakis for consultant services for a one-year period ending April 16, 1973; and

WHEREAS, said agreement was executed by and between The City of San Diego and Michael Babunakis, an individual, and filed in the office of the City Clerk as Document No. 739704; and

WHEREAS, it is now desired to extend the above mentioned agreement through June 30, 1973, under the same terms and conditions as originally agreed to by and between the parties thereto; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the consultant agreement between The City of San Diego and Michael Babunakis on file in the office of the City Clerk as Document No. 739704 be and the same is hereby amended by extending the term and expiration thereof from April 16, 1973 through June 30, 1973, under the same terms and conditions as contained in said document.

2. That the City Manager be and he is hereby authorized and empowered to execute on behalf of the City this first amendment to said agreement.

3. That the City Auditor and Comptroller be and he is hereby authorized to transfer the sum of \$5,112 within the 100 Fund from Unallocated Reserve (53.30) to City Council Fiscal Analyst (44.14) solely and exclusively for the purpose of providing funds for said consultant services.
