That the bid of \$18,580.00 by Silver Strand Contractors, a partnership, for the IMPROVEMENT OF SIDEWALKS, CURBS AND GUTTERS IN THE AREA BOUNDED BY 37TH STREET, OCEAN VIEW BOULEVARD, 38TH STREET, FRANKLIN AVENUE, 40TH STREET, LOGAN AVENUE, 41ST STREET AND NATIONAL AVENUE, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 742838.
