1. That the bid of \$74,856.00 by Rick Stadelman, an individual, dba R.S. Construction Co. for the CONSTRUCTION OF WATER RELOCATIONS FOR STATE ROUTE 163, BETWEEN AERO DRIVE AND CLAIREMONT MESA BOULEVARD, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 742751.
2. That the expenditure of \$128,000.00 is hereby authorized out of the Water Revenue Fund (502) of the City of San Diego solely and exclusively for the purpose of providing funds for the CONSTRUCTION OF WATER RELOCATIONS FOR STATE ROUTE 163, BETWEEN AERO DRIVE AND CLAIREMONT MESA BOULEVARD, in the City of San Diego, and related costs.
