<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Clifford M. Antijuntti	PUBLIC WORKS	\$80	The suggester, a Plumber, suggested that valves for sweat-fitting to tubing be carried in stock. Because they were not, the more expensive and difficult to install threaded valves had to be used. Estimated savings in material and labor amount to about \$800 per year.
Nancy J. Acevedo Catherine J. Rizzo	PERSONNEL	\$80	This joint suggestion by these two Clerks was to computerize employee leave balances for all departments so Personnel would no longer have to check each leave. About \$800 worth of time has been saved.
Nancy Lovell	PUBLIC WORKS	\$25	The preparation of out-of-class Change Notices was improved for a net saving of \$250 per year. The suggester is Intermediate Typist in the Sanitation Division.
Charles Kolar	POLICE DEPARTMENT	\$20	This Patrolman proposed elimination of the practice of stapling labor cards to subpoenas. It was found this could be done for a saving of \$200 per year.
Patricia DiGiacomo	EMPLOYEE SERVICES	\$20	At the time she was an Account Clerk in the Auditor's, the suggester designed an improved Labor Card Batch Control form which has saved about \$180 in Data Processing and the Auditor's.
