

RESOLUTION NO. 207836 MAY 1 1973

WHEREAS, on January 25, February 6, April 10 and May 1, 1973, the City Council conducted public hearings on the proposed amendment to the Mira Mesa Community Plan; and

WHEREAS, at today's hearing, May 1, Council heard further testimony, including a Report to Council signed by the City Manager and the Planning Director; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. The concept of a proposed phase plan as presented in the Report of April 10, 1973, is approved.
2. The proposed amendment to the Mira Mesa Community Plan, as approved by the Planning Commission and as presented to Council at said public hearings, is returned to staff.
3. Staff is instructed to prepare an amendment to the Mira Mesa Community Plan, as adopted in 1966, which will incorporate the phase concept as set forth in the Report to Council of April 10, 1973.
4. Planning Commission is directed to schedule a public hearing on the above phase plan as soon as it can be made available.
5. During the interim period, pending approval by Council of a modified phase plan, staff and Commission are directed to

process those zoning and tentative map requests which are in accordance with general concepts as approved in paragraph No. 1 above.
