2. That the expenditure of \$60,000.00 is hereby authorized out of the Sewer Revenue Fund (Fund 506) of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF UNITED STATES COAST GUARD AIR STATION SEWER SERVICE in the city of San Diego, and related costs.
