tools, equipment, transportation and other expense necessary or incidental for CONSTRUCTION OF TRAFFIC SIGNALS AND SAFETY LIGHTING SYSTEMS AT THE INTERSECTIONS OF 35TH STREET AND ADAMS AVENUE; COWLES MOUNTAIN BOULEVARD AND NAVAJO ROAD; BISBY LAKE AVENUE AND NAVAJO ROAD; PARK BOULEVARD AND UNIVERSITY AVENUE; PARK BOULEVARD AND PRESIDENT'S WAY; PARK BOULEVARD AND MORLEY FIELD DRIVE; CATALINA BOULEVARD AND TALBOT STREET; HOWARD AVENUE AND TEXAS STREET, San Diego, California

BE IT FURTHER RESOLVED, that the Purchasing Agent of The City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.
