BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by PETER A. HATLEM, Registered Civil Engineer, and entitled "EMERALD HILLS ANNEX UNIT NO. 3 Being a subdivision of a portion of Lot 18 of Rancho Mission of San Diego, in the City of San Diego, County of San Diego, State of California, according to partition map thereof made in an action entitled 'Juan M. Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
