FOWLER, husband and wife as joint tenants, executed in favor of The City of San Diego, bearing date of February 24, 1973, conveying to said City a portion of Lot G, Block 1, Mission Beach, as more particularly described in said deed, be and the same is hereby approved and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named BAYSIDE LANE.

BE IT FURTHER RESOLVED, that the expenditure of \$10,000 is hereby authorized from Gas Tax Fund 219 solely and exclusively to provide funds for the acquisition of right of way as stated above.

BE IT FURTHER RESOLVED, that the City Clerk of said City be and he is hereby directed to deliver said deed to the Property Director of The City of San Diego for recording and further disposition.
