PATLAF, a widower, executed in favor of The City of San Diego, bearing date of April 16, 1973, conveying to said City Lots 17 and 18 in Block 24 of Middletown Addition, according to Map thereof No. 384, as more particularly described in said deed, for park purposes, be and the same is hereby approved.

That the acceptance by the City Manager of that deed of CARL A. PATLAF and LUCILLE PATLAF, husband and wife, as joint tenants, executed in favor of The City of San Diego, bearing date of April 16, 1973, conveying to said City Lot 19 in Block 24 of Middletown Addition, according to Map thereof No. 384, as more particularly described in said deed, for park purposes, be and the same is hereby approved.

BE IT FURTHER RESOLVED, that the expenditure of \$10,344.00 is hereby authorized from San Diego Park District No. 3 Fund 3711 solely and exclusively to provide funds for the acquisition of land for park purposes as stated above.

BE IT FURTHER RESOLVED, that the City Clerk of said City be and he is hereby directed to deliver said deeds to the Property Director of The City of San Diego for recording and further disposition.
