BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that quitclaim deed of THE UNITED STATES OF AMERICA, bearing date of October 20, 1972, quitclaiming to The City of San Diego a portion of Lot 73, Rancho Mission of San Diego, according to the Partition Map thereof, and Lots 2 and 3 of the Resubdivision of a portion of Fanita Rancho, as more particularly described in said deed, be and the same is hereby approved on the conditions therein expressed; and the lands therein conveyed are hereby set aside and dedicated for public park purposes.

That the City Clerk is hereby authorized and directed to deliver said deed to the Property Director, upon acceptance by the City Manager, for further handling.
