

RESOLUTION NO. 207949 MAY 17 1973

APPROVING MAP OF VISTA BAY HO SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by DON NASLAND, Licensed Land Surveyor, and entitled "VISTA BAY HO Being a portion of Pueblo Lot 1787 of The Pueblo Lands of San Diego, in the City of San Diego, County of San Diego, State of California, according to Map thereof made by James Pascoe in 1870, a copy of which said Map was filed in the office of the County Recorder of San Diego County, November 14, 1921 and known as Miscellaneous Map No. 36, together with a portion of Morena Boulevard as dedicated to public use.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following street and portions of streets: Conner Court, a portion of Nute Way and a portion of Hunrichs Way, for public purposes, and said street and portions of streets are hereby declared to be a public street and portions of public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access: in and to Nute Way, adjacent

and contiguous to Lot 1; in and to Hunrichs Way, adjacent and contiguous to Lots 1 and 2; in and to Slayen Way, adjacent and contiguous to Lots 5 and 6, all as shown on this map within this subdivision; together with the easement with the right of ingress and egress for the construction and maintenance of drainage facilities as granted on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public street and portions of public streets are accepted on behalf of the public as heretofore stated; and that those certain abutters' rights of access, together with the easement with the right of ingress and egress for the construction and maintenance of drainage facilities as granted and shown on this map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
