

RESOLUTION NO. 207963 MAY 17 1973

WHEREAS, STAR BEVERAGE COMPANY, by Marvin E. Gustafson, applied to the City Council for special permission to waive underground utility requirements on Vandever Avenue and Fairmount Avenue in connection with the subdivision known as CEE GEE PARK UNIT NO. 1; and

WHEREAS, STAR BEVERAGE COMPANY, subdivider of said subdivision, has signed a restrictive covenant agreeing not to oppose future 1911 Act underground utility installation on Vandever Avenue; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. The request of STAR BEVERAGE COMPANY to waive the requirement to underground the utilities in CEE GEE PARK UNIT NO. 1 is granted to the extent utilities on Vandever Avenue need not be placed underground until such time as an improvement district is formed to undertake such work.

2. The request relating to utilities on Fairmount Avenue is denied.
