Werden Contracting Co., an individual, for IMPROVEMENT OF SIDEWALKS, CURBS AND GUTTERS IN THE AREA BOUNDED BY EVANS STREET, "K" STREET, 30TH STREET AND COMMERCIAL AVENUE (CONTRACT No. 24) in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 742837.
