Werden Contracting Co. for the IMPROVEMENT OF SIDEWALKS, CURBS AND GUTTERS IN THE AREA BOUNDED BY "G" STREET, 27TH STREET, ISLAND AVENUE, 28TH STREET, EVANS STREET, IMPERIAL AVENUE AND 25TH STREET (CONTRACT 26), in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 742839.
