1. That the bid of \$28,712.50 by Sapper Construction Co., a corporation, for the IMPROVEMENT OF SIDEWALKS, CURBS AND GUTTERS IN THE AREA BOUNDED BY WABASH BOULEVARD, IMPERIAL AVENUE, 33RD STREET, COMMERCIAL STREET, 30TH STREET, CLAY STREET, 32ND STREET AND OCEAN VIEW BOULEVARD (CONTRACT 27) in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 742840.
