Adopted on MAY 22 1973

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. Triangle Steel & Supply Company 2. Western Metal Supply and 3. Wilson F. Clark Co. are hereby accepted, and the City Manager is hereby authorized to execute contracts for the purchase of **HARDWARE AND FASTENERS** as may be required for the period of one (1) year beginning July 1, 1973 through June 30, 1974, per prices on file in the Purchasing Department as follows:

1. Triangle Steel & Supply Company for Section I; terms 2% 30 days, plus sales tax, subject to price escalation not to exceed 8.2% of bid price, and;
2. Western Metal Supply for Sections II, III and IV; terms 2% 30 days, plus sales tax, subject to price escalation not to exceed 10% of bid price, and;
3. Wilson F. Clark Co. for Section V; terms 2% 30 days, plus sales tax, subject to price escalation not to exceed 10% of bid price.
