

RESOLUTION NO. 207984 MAY 22 1973

APPROVING MAP OF HOLLY HILLS VISTA UNIT NO. 6 SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:


Said Council hereby finds that that certain map surveyed by M. KENT JOHNSON, Registered Civil Engineer, and entitled "HOLLY HILLS VISTA UNIT NO. 6 Being a subdivision of portions of Lots 17 through 21 of Block K, Narragansett Heights, and a portion of Carlsbad Street (formerly San Miguel Avenue) in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 1041, filed in the office of the County Recorder of San Diego County, April 5, 1907.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following street and portions of streets: Osage Street, a portion of Carlsbad Street, and a portion of Innsdale Avenue, for public purposes, and said street and portions of streets are hereby declared to be a public street and portions of public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement with the right of ingress and egress for the construction and maintenance of drainage facilities, as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public street and portions of public streets are accepted on behalf of the public as heretofore stated; and the easement with the right of ingress and egress for the construction and maintenance of drainage facilities as granted and shown on this map within this subdivision is accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
