

**RESOLUTION No. 207984**

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Auditor and Comptroller is hereby authorized to transfer \$175,000 within the Sewer Revenue Fund 506, \$171,000 from Construction Activity 68.58 to Metropolitan Sewage Pump Station No. 1 (Activity 62.30) - Non-Personal Expense and \$4,000 from Unallocated Reserve Activity 68.91 to Metropolitan Sewage Pump Station No. 1 (Activity 62.30) - Personal Services for repairs to pump station due to explosion and fire.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and empowered to use City forces to repair gratings, hand rails, ladders, ventilation fans, wiring, light fixtures and intake duct work. The cost of said work shall not exceed \$14,100.
