WHEREAS, the Planning Commission of The City of San Diego has recommended approval of the renaming of a 30-foot wide north-south portion of Caithness Drive, northerly of Beyer Boulevard, to Del Sur Boulevard; and a 60-foot wide east-west portion of Caithness Drive, between Athey Avenue and Del Sur Boulevard, to Athey Avenue; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that a 30-foot wide north-south portion of Caithness Drive, northerly of Beyer Boulevard, as more particularly shown on Drawing No. 13047-B, on file in the office of the City Clerk as Document No. 743577, be and the same is hereby renamed DEL SUR BOULEVARD; and a 60-foot wide east-west portion of Caithness Drive, between Athey Avenue and Del Sur Boulevard, as more particularly shown on Drawing No. 13047-B, on file in the office of the City Clerk as Document No. 743577, be and the same is hereby renamed ATHEY AVENUE.

BE IT FURTHER RESOLVED, that the City Clerk of said City is hereby directed to file a certified copy of this resolution in the office of the County Recorder and the County Surveyor of San Diego County.
