

RESOLUTION No. 208002

Adopted on MAY 22 1973

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby directed to prepare plans, drawings, typical cross-sections, profiles and specifications for the improvement by grading and paving MIRA MESA BOULEVARD from its present westerly terminus approximately 2800 feet westerly of Camino Ruiz to I-805 in the City of San Diego, together with estimates of the costs and expenses of such work and to furnish this Council with a description of the district and a plat showing the exterior boundaries of the district to be included in the assessment for the work and improvement hereinabove mentioned, said work to be done under the Improvement Act of 1911.
