BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute for and on behalf of said City a Second Amendment to that certain Operating Agreement--Balboa Park Zoological Gardens, a copy of which agreement is on file in the office of the City Clerk as Document No. 727222, with the ZOOLOGICAL SOCIETY OF SAN DIEGO, INC.; to allow for a change in the fiscal year of the aforesaid Zoological Society from July 1 to June 30 to from January 1 to December 31; and to provide for the establishment by the Zoological Society of an Affirmative Action Program satisfactory to the City Manager and comparable to the Affirmative Action Program for The City of San Diego, a copy of which City Program is on file in the office of the City Clerk as Document No. 739643; under the terms and conditions set forth in the form of Second Amendment to Agreement on file in the office of the City Clerk as Document No. 743586.
