

RESOLUTION NO. 208007

Adopted on MAY 22 1973

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Phillip E. Reyes	PUBLIC WORKS DEPARTMENT Buildings Division	\$70	Mr. Reyes is a Utilityman. He observed that in the Balboa Park Botanical Building reconstruction the lower timbers being removed could be largely salvaged and used for the shorter upper parts of the structure. This has been done for a saving of \$714 worth of lumber.
Janet A. Reed	WATER UTILITIES	\$65	The suggester, a Payroll Clerk, found that many extra time cards were being prepared and processed through payroll operations. Arrangements were made to prepare only the number needed. This saves a total of \$643 per year in clerical time, computer costs and cards.
Donna J. Evans	POLICE DEPARTMENT	\$60	In burglary cases, the Detective reports to the victim by phone, and then a follow-up letter is sent confirming the call and giving the case number etc. It was suggested that a form card be used, requiring much less time to prepare and less postage. \$597 per year will be saved.
Gail F. Geromin	PROPERTY DEPARTMENT	\$30	The suggested use of three form letters to replace regular typed letters has saved \$288 a year in the time of both Property Agents and Typists.
Charles B. Simon	FIRE DEPARTMENT	\$20	This Fire Fighter proposed a positive means of holding blades in rescue saws. These formerly tended to shatter and fly through the air. This award is recommended because of increased safety and a saving of blades.
