

RESOLUTION No. 208017

Adopted on MAY 24 1973

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the expenditure of \$1,678.00 from Gas Tax Fund 220 of The City of San Diego is hereby authorized solely and exclusively for the purpose of providing funds for the modification of traffic signal systems at the intersections of (1) Cedar Street and Pacific Highway and (2) Genesee Avenue and Linda Vista Road, in the City of San Diego.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized and empowered to do by City Forces all necessary work in conjunction with the above referenced project of modifying the traffic signal systems at the intersections of (1) Cedar Street and Pacific Highway and (2) Genesee Avenue and Linda Vista Road, in the City of San Diego, pursuant to the recommendation of the City Manager and the submission of his estimates indicating that said work can be done more economically by City Forces than if let by contract.
