That the expenditure of \$573.00 from Gas Tax Fund 220 of The City of San Diego is hereby authorized solely and exclusively for the purpose of providing funds for the modification of the traffic signal system at Navajo Road and Park Ridge Boulevard, in the City of San Diego.

BE IT FURTHER RESOLVED, that the City Manager be, and he is hereby authorized and empowered to do by City Forces all necessary work in conjunction with the above referenced project of modifying the traffic signal system at Navajo Road and Park Ridge Boulevard, pursuant to the recommendation of the City Manager and the submission of his estimates indicating that said work can be done more economically by City Forces than if let by contract.
