

RESOLUTION NO. 208029 MAY 24 1973

WHEREAS, solid waste disposal has become a matter of extreme concern to the citizens of San Diego and to the Nation as a whole; and

WHEREAS, it has been recognized by this Council that said solid waste disposal is a regional problem as evidenced by the adoption of Resolution No. 207558 on March 20, 1973 approving in concept the formation of a joint City-County task force for the preparation of a Regional Solid Waste Management Plan; and

WHEREAS, in September of 1972 the County of San Diego received a \$2.96 million federal grant to design, construct and operate a demonstration Solid Waste Resource Recovery Plant; and

WHEREAS, in order to make this demonstration project economically feasible, its location should be such that it would substantially reduce hauling distances and be centrally situated; and

WHEREAS, The City of San Diego is desirous of cooperating fully with the County in order to accomplish the objectives set forth above and is now in possession of approximately five acres of land which has been recommended as a suitable location site for said project by the City Manager; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the Council of The City of San Diego hereby approves in principle the intended use of approximately five acres of City-owned land (Water Utilities), situated within the City of San Diego on Sunset Drive immediately adjacent to the Interstate 15/Bear Valley Road Interchange, by the County of San Diego for use as a demonstration Solid Waste Resource Recovery Center.

2. That the City Manager be and he is hereby authorized to negotiate a lease of said property subject, however, to final Council approval of the lease agreement.

3. That prior to The City of San Diego entering into a final lease or option agreement, a final Environmental Impact Report or Negative Declaration shall be available to this Council for its consideration in conjunction with this project.
