RESOLUTION ADOPTING PLANS AND SPECIFICATIONS TO PAVE AND OTHERWISE IMPROVE BLUERIDGE STREET AND CHATTANOOGA STREET EASTERLY OF RACHAEL AVENUE, AND THE CONSTRUCTION OF A SEWER MAIN IN RACHAEL AVENUE BETWEEN BLUERIDGE STREET AND HOPKINS STREET, AND IN A PORTION OF BLOCK 39, PARADISE HILLS UNIT NO. 2.

BE IT RESOLVED, by the Council of The City of San Diego, that the plans, drawings, typical cross-sections, profiles and specifications submitted by the City Engineer and filed in the office of the City Clerk on MAY 23 1973 under Document No. 743570, to:

Pave and otherwise improve Blueridge Street and Chattanooga Street easterly of Rachael Avenue, and the construction of a sewer main in Rachael Avenue between Blueridge Street and Hopkins Street, and in a Portion of Block 39, Paradise Hills Unit No. 2, be, and the same are hereby approved and adopted as the official plans, drawings, typical cross-sections, profiles and specifications for said work and improvement.

BE IT FURTHER RESOLVED, that Plat No. 3856, showing the exterior boundaries of the district to be included in the assessment for the work and improvement upon the street(s) hereinabove mentioned, be, and the same is hereby approved.
