

RESOLUTION NO. 208051 MAY 29 1973

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN DIEGO, CALIFORNIA, ORDERING CERTAIN CHANGES AND MODIFICATIONS IN THE BOUNDARIES OF THE IMPROVEMENT OF PRINCESS VIEW DRIVE FROM MISSION GORGE ROAD TO WARING ROAD, PURSUANT TO CHAPTER 8.5, DIVISION 7 OF THE STREETS AND HIGHWAYS CODE.

WHEREAS, this City Council did on October 12, 1971 adopt Resolution of Intention No. 203936, declaring its intention to order the construction of certain improvements in the City of San Diego; and

WHEREAS, several properties within the district boundary have filed subdivision maps since approval of the plat by the City Council and slight adjustments of the district boundaries are desirable to make those boundaries coterminous with the subdivision lot lines; and

WHEREAS, this Council now proposes to make certain changes and modifications in the boundaries of the district described in said Resolution of Intention; and


WHEREAS, all of the owners within the district have filed petitions waiving all rights to notice and hearing for the aforesaid change, copies of which petitions are on file in the office of the City Clerk as Document No. 743626, and this Council now having jurisdiction to make said changes and modifications; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

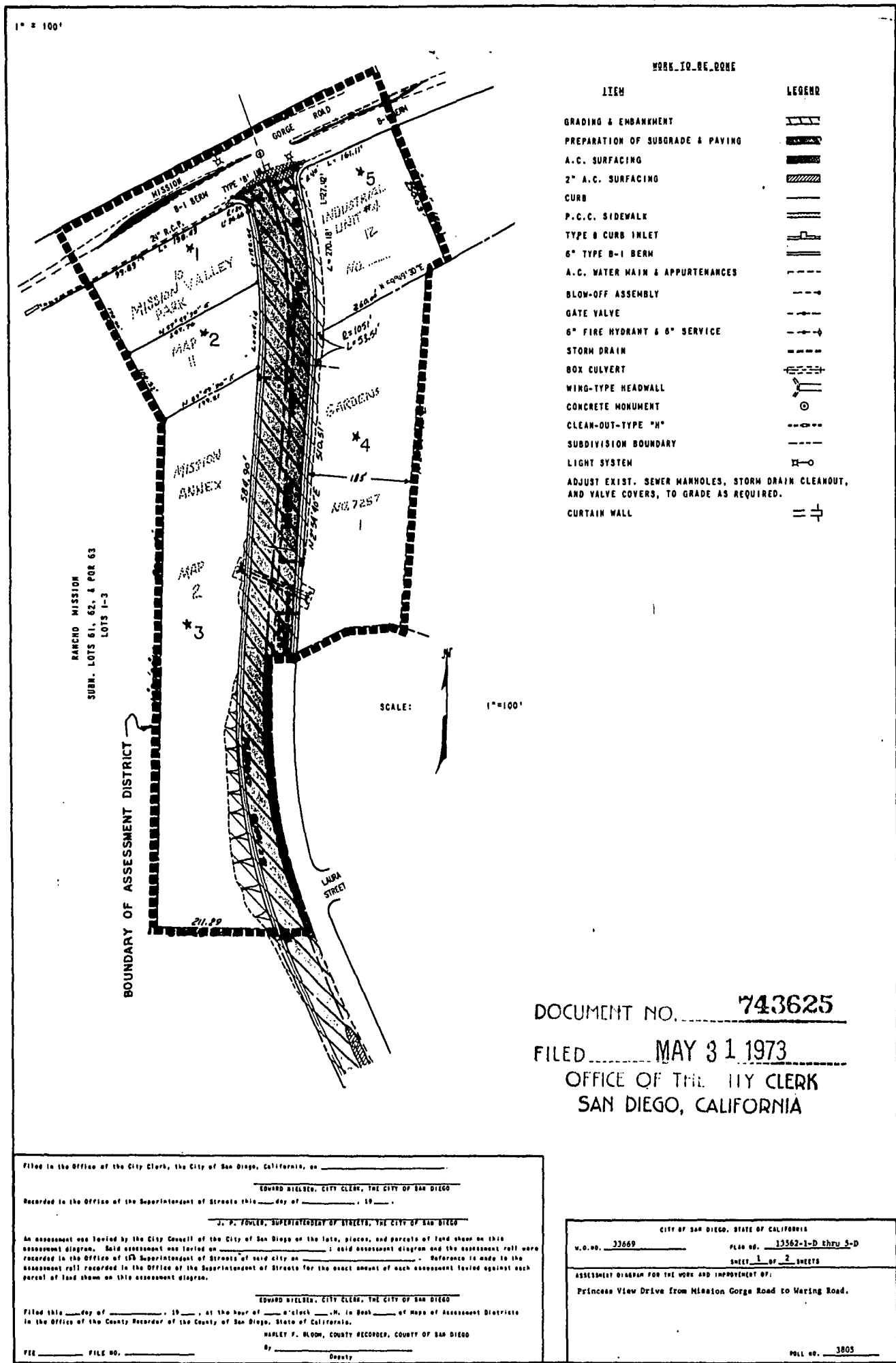
Section 1. Public interest and convenience require certain changes and modifications in the boundaries of the assessment district originally set forth in Resolution of Intention No. 203936, which changes and modifications are duly described and set forth in Document No. 743625, a copy of which is on file in the office of the City Clerk. This Council hereby orders said changes and modifications as set forth in said Document.

Section 2. That the contract for said improvement entered into for the doing of the work shall be modified to include modifications ordered by this resolution.

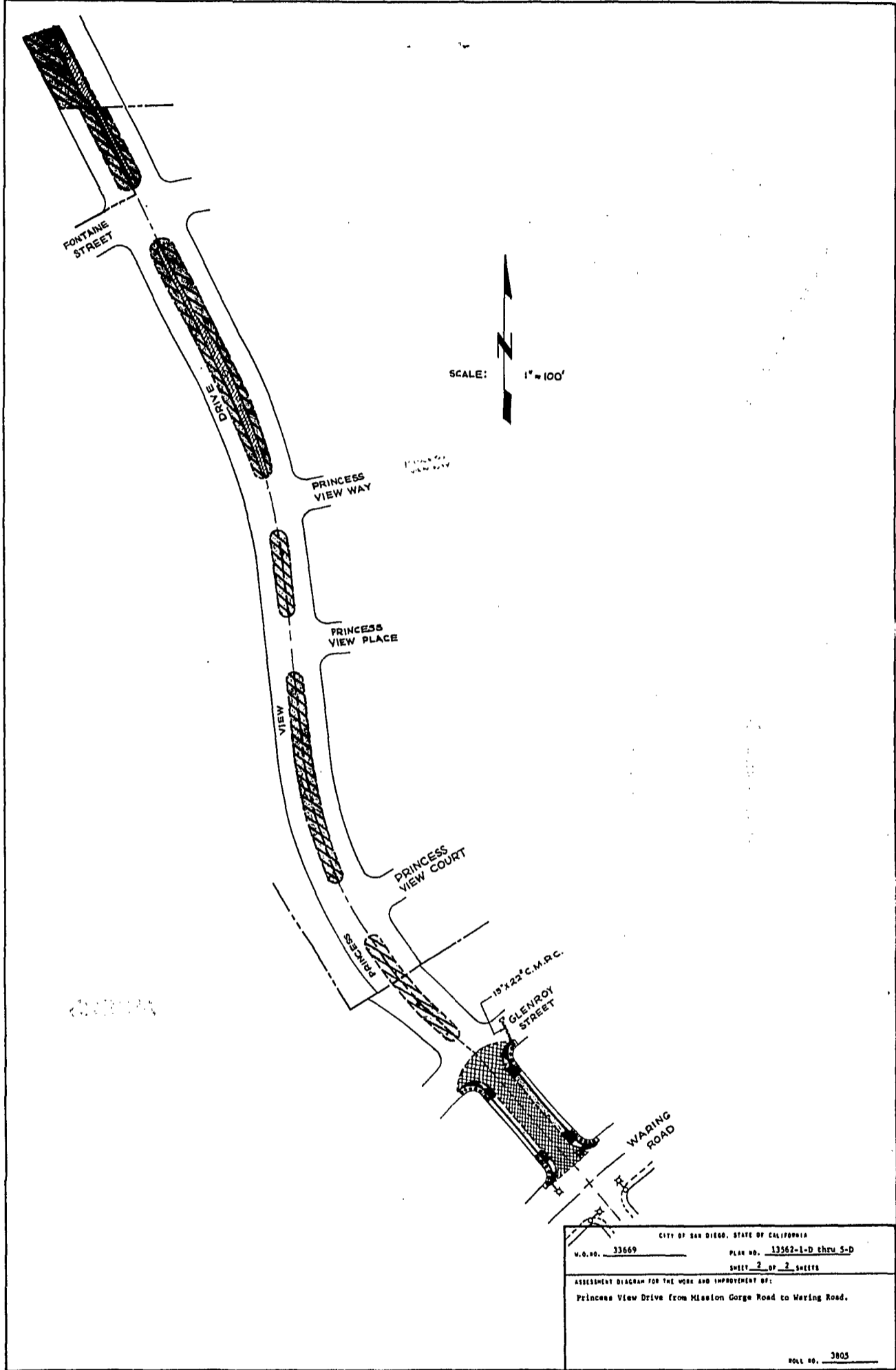
