1. That the bid of \$26,840.00 by T.B. Penick & Sons, Inc., a corporation, for the IMPROVEMENT OF SIDEWALKS, CURBS AND GUTTERS IN THE AREA BOUNDED BY DEWEY STREET, HARRISON AVENUE, EVANS STREET, OCEAN VIEW BOULEVARD, SAMPSON STREET, FRANKLIN AVENUE, 28TH STREET, HARRISON AVENUE, SAMPSON STREET AND IRVING AVENUE (CONTRACT 35) in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 742904.
2. That the expenditure of \$31,000.00 is hereby authorized out of Special Fund (Fund No. 2714) of the City of San Diego solely and exclusively for the purpose of providing funds for the IMPROVEMENT OF SIDEWALKS, CURBS AND GUTTERS IN THE AREA BOUNDED BY DEWEY STREET, HARRISON AVENUE, EVANS STREET, OCEAN VIEW BOULEVARD, SAMPSON STREET, FRANKLIN AVENUE, 28TH STREET, HARRISON AVENUE, SAMPSON STREET AND IRVING AVENUE (CONTRACT 35) in the City of San Diego, and related costs.
